This application system is an innovative breakthrough from BPPBJ DKI Jakarta, as a forum to bridge the activities of purchasing MSME products (as providers) with DKI Jakarta Provincial Government institutions (SKPD) and make payments to micro and/or small businesses no more than 3 (three) working days, and the Commitment Making Officials (PPK) make procurement documents in the form of Terms of Reference (KAK), Self-Estimated prices (HPS) and specifications of goods/services through Micro and/or Small Business actors registered in the e-Order system, as well as receiving the work of Micro and/or Small Business providers.

Through the Instruction of the Governor of DKI Jakarta Number 48 of 2020 which was replaced by Governor's Instruction Number 29 of 2021 concerning Direct Procurement Transactions with Businesses Micro and/or Small Businesses through the e-Order system, explained that the Head of BPPBJ provide an integrated system that facilitates transactions through the e-Order system, as well asurge Budget Users/Power of SKPD Budget Users/SKPD Units to do direct procurement of dining activities and minimal meetings through the e-Order system.

E-Order BPPBJ DKI Jakarta is the online marketplace of DKI Jakarta MSMEs, this application system is an innovative breakthrough from BPPBJ DKI Jakarta, as a forum to bridge MSME product purchase activities (as providers) with DKI Provincial Government institutions Jakarta (SKPD) and make payments to micro and/or small businesses no more from 3 (three) working days, and the Commitment Making Officers (KDP) make procurement documents in the form of Terms of Reference (KAK), Self-Estimated Prices (HPS) and specifications of goods/services through Micro and/or Small Business actors registered in the e-Order system, and receive the work of Micro and/or Small Business providers

The huge Regional Budget (APBD) of DKI Jakarta Province must be allocated absorption to the use of domestic products by 40%. In addition, the problem of server systems that are often down and websites that cannot be accessed for hours, slow internet connection access, lack of human resources in using and understanding electronic procurement applications and the complexity of SPJ (Letter of Accountability) administration are still problems in the implementation of collaboration through the e-Order application information system.

The growth of entrepreneurship and the creation of new industries are still limited to efforts to meet local consumption needs or the environment in which the business is located. In business, the condition of small businesses is still relatively weak, the condition of MSMEs is caused by their limitations. c) Solutions to obstacles to budget realization related to payment of direct procurement transactions with MSMEs in DKI Jakarta Province, The need for strong communication and cooperation between the Executive and Legislature in DKI Jakarta Province to realize effective and efficient governance to improve government performance and public services, it is necessary to simplify bureaucracy through simplification of SPJ, Delegation of overlapping tasks, and adjustment of work systems to create a dynamic, agile,
